Numerous ESP Retirees joined the Cooperative Extension Centennial Committee and served on most of the sub-committees to ensure a successful celebration in 2012. Mary Beatty, member of the History Committee, was busy writing stories for posting on the Centennial website (http://100.ces.uwex.edu/) and engaged other retirees to join him in writing. The stories are wonderful! Throughout 2013, we would like to share a few of these stories with you.

In November of 1961, I stopped at Ag Hall to say hello to my undergraduate advisor, Dr. Gale Vandeberg. I was working for the International Harvester Corporation at the time. Gale happened to be in his office and proceeded to tell me about a new position that was to be established in Columbia County.

The University had received a Ford Foundation grant; a small portion of the grant was earmarked for Cooperative Extension, to be used to carry out a pilot project to extend University resources to new clientele. He urged me to apply. Details were scarce, but for the next several days I couldn't help but think about the concept, excited at the possibility of being a part of such an effort. My undergraduate degree was, after all, in "Extension Education."

The guidelines were broad, and such a project had never been attempted in a single county. A few agents in northern Wisconsin had carried out



regional programs in recreation and tourism. Sherm Weiss was one of these early agents.

I applied for the position and was selected by the District Director and the Columbia County Extension Committee. When my wife asked what I would be doing, at that point I had some difficulty describing what that would be. The starting salary was \$7,000 (that's per year, not per month). I started on January 2, 1962.

Columbia County was a progressive county with a long history of good Extension programs and solid support of those programs. New clientele was not hard to find; the challenge rather was to match University personnel and resources to the problems and opportunities. We reached over 1,000 small business people with educational programs the first year alone.

We worked closely with community leaders as we planned and built our programs. Initial citizen surveys, which identified priorities and opinions, were an important part of the program. These surveys also identified the power structure. As priorities and needs were identified, we designed projects and programs to address them. I had countless meetings with Chambers of Commerce, local governments, small businesses, and industry and community leaders. Most programs and meetings took place in the evenings; the hours were long but productive.

Cooperative Extension and General Extension at that time were separate arms of University Extension. In the Columbia County project we found many ways to extend both through a county extension office. In later years these two Extension outreach services were merged into a single UW-Extension. We like to think that the Columbia County experience facilitated that process.

After the initial three years of Ford Foundation funding, the Columbia County government voted to continue the Resource Development position on a similar financial arrangement as other county Extension positions (Youth, Home Economics, and Agriculture). The success of the project caused other counties to establish similar positions, and the Community Development Program became established in the UW-Extension.

As the program expanded to other counties, resource agents requested specialist support at the state level. Training programs were developed for community development resource agents in the field.

This is a very brief overview of an important part of Extension's history. I was fortunate to be a part of the founding of a key program. It was an exciting time, and an example of the University of Wisconsin meeting citizen needs, something we all know as the "Wisconsin Idea."


Greetings fellow ESP members! The ESP Awards Committee has begun their work. We received nominations/applications to review in six award categories.

YOUR WISCONSIN RETIREMENT FUNDS IN ACTION

The stock market was volatile but generally up for 2012. The market closed the first half up with the best June since 1999. August was the second best for 86 years since 1926. The third quarter closed with the Dow up 10% and the S&P 500 up 14.6% for the year, indexes within shouting distances of all time highs. At year's end, the Dow was up 7.3%, the S&P 500 up 13.4%, and the Nasdaq up 15.9% for the year, the best year since 2009.

The Dow surged at the start of 2013 and had the best January in nearly two decades. As of this writing, the Dow rose to its highest close of the year placing it within one percent of the record close of 14,164.53 in October 2007. It reached 14,000 several times during this period. With the major indexes near record highs, many think this stock market's six-week rally is ready for a correction. Solid earning reports have helped feed the rally—typical stocks appear fairly priced compared to earnings, corporations keep finding ways to boost profits, and Americans having few alternatives are looking for places to put their savings. The best year for stocks measured by the S&P 500 was 1933 in the midst of the Great Depression.

Wisconsin Retirement System (WRS) Pensions WRS funds followed the stock market trends with the Core trust fund closing up 13.6% and the Variable Trust fund up 16.9% for the year on December 31, 2012. Both funds closed above their bench marks. WRS members want to know what to expect for this year's effective rates that apply to active employees and the annuity adjustments to retirees for both funds.

Employee Trust Funds made the following projections based on December returns

	Core Fund	variable Fund
SWIB Investment Return	13.6%	16.9%
Effective Rate	1.8% to 2.2%	13% to 15%
Annuity Adjustment	0% to -13%	7% to 9%

The effective rates are the starting point for calculating the annuity adjustments for retirees. The annuity adjustments are approximately 5% to 8% lower because there is already a 5% earning assumption built into the initial benefit amount paid to retirees. In addition, actuarial factors such as mortality, carryover, etc. are factors in the adjustment calculation process. Remember you can never go below your initial annuity amount or floor.

Of the 165,000 annuitants, 54% or 71,000 will not have a loss, 36,000 or 22% will have a partial loss, and 42% or 61,000 will experience the full loss in the Core fund. Who will pay the loss? Those that retired in 2008 to 2012 have never received an increase, so will have no loss; 2005 to 2007 have previously lost all increases; 2000 to 2004 will lose any remaining increases; and 1999 and before will experience the full expense.

This will be the last reduction from the 2008 loss of 26% in the Core Fund. Core Fund gains or losses are smoothed over five years. Losses paid to date are in 2009 -2.1%, 2010 -1.3%, 2011 -1.2%, 2012 -7%, and 2013 -0 to -13%. If you were also in the Variable in 2012, you may break even or make money this year, depending when you retired.

The Future SWIB (State of Wisconsin Investment Board) has been able to earn positive returns each year in the Core Fund and in three of the last four years in the Variable Fund. Over the last ten years, the Core Fund has had eight years of positive returns while the Variable Fund has had seven years of positive returns. To assure that WRS remains solid, a number of initiatives have been adopted to help meet the goals of SWIB and the WRS. The investment strategy continues to focus on managing risk and reducing costs. Increasing amounts of investments have been moved in-house to save WRS money, and they will consider ways to cut costs. Because the biggest risk is the stock market, which accounts for 84% of the risk, exposure to stocks has been reduced by 5% over the past three years. Because 75% of the assets in the trust funds come from returns on investments, SWIB will continue to diversify holdings to protect from severe market downturns and better protect participants. If SWIB achieves its target of 7.2% for the Core, we should be in a position to receive a positive annuity in 2014.

Federal: Remember you are receiving a 1.7% COLA on your Social Security and Federal pension.

IN MEMORIAM -- We are saddened to share that we received information of losing 3 friends and colleagues since our last newsletter.

<u>Laurel Huibregtse</u>, age 85, died unexpectedly as a result of an accident on November 27, 2012. A graduate of the UW-Madison, Laurel majored in food service administration. She served as the Eau Claire County Home Economist in the 1950s. Laurel and her husband Don published community newspapers in Wisconsin from 1953 until their retirement in 1988. She also was the director of school food service for the Monona Grove school district from 1969 to 1989. All family members and countless friends considered Laurel to be the best cook they had ever encountered. Laurel was a many year member of the Monona Branch of the American Association of University Women and served on its Board and as its President. With three friends, she started a gourmet dining club for twelve couples, which has continued to meet since 1972. An avid bridge player, she was proud to be a Life Master.

Everett Earl Olsen, age 89, died January 17, 2013. Following service in the U.S. Navy during World War II, he returned to UW-Madison to complete his interrupted study for a degree in agriculture. Everett and his wife, Zella, settled in Dodgeville where he worked for the UW-Extension as a Resource/County Agent for more than 30 years. He returned to the UW from 1965 to 1968 to complete his master's degree in Extension Education. One of his accomplishments as a County Resource Agent was assisting SCS and DNR with three multipurpose flood control/recreation areas in lowa County. Everett was an environmentalist and community activist who was involved in the formation of the Uplands Group to promote tourism and the economy in lowa County. He was also a founding member of the lowa County Historical Society.

<u>Dennis Presser</u>, age 54, died unexpectedly of natural causes on February 16, 2013. Dennis earned his Bachelor of Arts degree in Humanities from North Dakota State and went on earn master's degrees in Public Administration and Urban and Regional Planning from UW-Madison. He served UW-Extension as the Juneau County CNRED Agent. Dennis was an avid conservationist, hunter and trout fisherman and held active roles in many conservation organizations. He also served his country in both the US Army and the National Guard. Dennis was much loved by many for his humor and full-hearted generosity and, to his last day, lived his life fully.


